



## **SIXTH TRIENNIAL**

Since 2001, the National Association of REALTORS® requires all members to complete a course on the Code of Ethics of the NAR. We are now in the sixth Triennial period of:

**January 1, 2019 – December 31, 2021.**

*Members are required to then email or fax us a copy of their certificate of completion for our review.*

*Members of the Board (excluding Affiliates, Institute Affiliates and REALTOR® Emeritus Members) must complete this training. There is no grandfathering provision and no exemption for Appraisers (as they hold REALTOR® membership) and Attorneys holding REALTOR® membership. There are no extensions to the due date.*

### **Below are your In-Class & Online options for completing the REALTOR® Code of Ethics class throughout 2020.**

**1. IN-PERSON:** Classes will be offered primarily at our offices at 2178 Mendon Road, Suite # 400, Cumberland, RI 02864. (There is ample parking.) Instructor for all classes is Stephen Antoni. The course is approved for 3 CORE Rhode Island real estate CEU's by the Department of Business Regulation. (GPBOR course # 100.) Cost is \$35 for members and \$55 for non-members. Please state that you are a member of the Northern Rhode Island Board of REALTORS®. A minimum number of students is required for the class.

**2. ON WWW.NAR.REALTOR:** Successfully complete the National Association of REALTORS® online 6th Biennial REALTOR® Code of Ethics Course. You may select either “New Member” (if you are a new member of the Association and are taking the course for the first time) or “Existing Member” (not for new members). These courses are available to all members at any time (24/7) on [www.nar.realtor](http://www.nar.realtor):

- a. Visit <https://www.nar.realtor/about-nar/governing-documents/code-of-ethics/code-of-ethics-training>
- b. Select either “new member” or “existing member”, whichever applies to you.
- c. On the next screen enter your first and last name OR your [9-digit NRDS member ID number](#).
- d. Note: You do not receive continuing education credits if you select the free course.

3. **ON WWW.NRIBR.REALTOR:** Simply go to the bottom of our home page and click on [The CE Shop](#) logo and select either **Course #C006**(Code of Ethics: “Good for your clients and your business”) OR **Course #C008** (Code of Ethics in Action: Real-Life Applications.”). There is a fee for the class, but it offers 3 CORE CEU’s.
