This is a courtesy notice. Your 2021 REALTOR® dues are **estimated*** to be between \$596.50 and \$695.50.* This represents your **three-part** membership in the Northern Rhode Island Board of REALTORS®, RI Association of REALTORS® and National Association of REALTORS®, as well as two optional contributions. Please read below for more details.

**As of 8/1/2020 the RIAR dues for 2021 have not yet been determined, which may necessitate additional charges to your card on 10/30/20, should their dues increase from their 2020 rate of \$196.50. NRIBR Annual Dues are \$215 and National are \$185.*

Your 2021 REALTOR® dues **are payable in advance by 10/31/2020** in accordance with Article X, Section 3 of the Board's Bylaws. Our Board is responsible for billing and collecting annual dues for your membership in the Northern Rhode Island Board of REALTORS®, RI Association of REALTORS® and National Association of REALTORS®.

Current members ONLY may elect to participate in a limited-time promotion. **Act now before the deadline of 5 pm EST on 8/10/2020. No forms will be accepted after that date and time – no exceptions, no extensions. Incomplete, illegible forms will not be accepted.** Payments will be equally charged to your Credit Card only on 8/30/20 and 10/30/20. There is a \$20 fee to participate in this dues payment plan.
